Corruption and Bribery Offences in Fiji
Penal Code ('PC')
Section 106 - 'Official Corruption'
Section 108 'Public Officer receiving Property to show Favour'

Crimes Decree 2009 ('CD')
Section 134 – Bribery of public officials
Section 135 - Receiving a bribe
Section 136 – Corrupting benefits given to, or received by, a public official
Section 137 - Receiving a corrupting benefit

Corruption and Bribery Offences in Fiji

- Prevention of Bribery Promulgation ('POBP') 2007
 - Section 3 Soliciting or accepting an advantage
 - Section 4 Bribery
 - Section 5 Bribery for giving assistance, etc, in regards to contracts
 - Section 6 Bribery for procuring withdrawal for tenders
 - Section 7 Bribery in relation to auctions
 - Section 8 Bribery of public servants by persons having dealings with public bodies
 - Section 9 Corrupt transactions with agents

Bribe?

 'property or benefit of any kind' [section 106 PC and section 133 CD]

'advantage' [section 2 POBP] which includes
 any gift, loan, fee, reward or commission consisting of money, or of any valuable security or of other property or interest in a property of any description;

Persons who may commit Bribe or Corruption

• Public Officer

Is one "**who discharges any duty in the discharge of which the public are interested**" (R v Whitaker [1914] 3 KB 1283)

Penal Code definition 'persons employed in the public service'

Prevention of Bribery Promulgation (POBP)
 Covers bribery of "public servants" which covers 2 categories of persons as 'prescribed officers' and 'employees of public bodies'

Crimes Decree definition
 "public officials"
 'corporations'

Effects on Society

- Betrayal of public trust
- Erodes public confidence in our government institutions.
- Serious crimes impeaching on high official offices in government.

Active Bribery (s4(1) POBP)	\$500,000 and 7 years imprisonment	
Passive Bribery (s4(2) POBP)

\$100 to official to quicken legal process

Supervisor collects monies from workers overtime pay
