

# FIU Policy Advisory

**Financial Transactions Reporting Act** 

Reference: 1/2020

Date: 11 September 2020

#### Re: Removal of Business Licence Requirement under the FTR Regulations

This Policy Advisory is issued pursuant to section 25(1)(j) of the Financial Transactions Reporting (FTR) Act and regulation 21(6) and 35 of the FTR Regulations to provide guidance to financial institutions on the requirements of the FTR Act and the FTR Regulations.

### A. Application of Policy Advisory

- 1. This *Policy Advisory* is applicable to all financial institutions (including lawyers, accountants and real estate agents) and is effective from 1 August 2020.
- B. Purpose of Policy Advisory
  - 2. The purpose of this *Policy Advisory* is to provide further guidance and clarification on the removal of the business licence certificate from the customer due diligence requirement under the Financial Transactions Reporting (FTR) Regulations.

### C. FTR Regulations Amendment

- 3. The Business Licence Act 1976 was repealed on 31 July 2020. The FTR Regulations was also amended as follows by:
  - a. deleting <u>"municipal business licence certificate or</u>" in regulations 8(2)(e); and
  - b. deleting paragraph (e) <u>"where the customer is a business, either for</u> profit or otherwise, the business licence from the relevant local <u>authorities or from the municipal council"</u> in regulation 10(1).
- 4. FIU Enforceable Guideline 4 is hereby also amended by:
  - a. deleting <u>"municipal business licence certificate"</u> in Appendix 1 List B(v) and Appendix 2 B(5) and replacing with "Certificate of Registration of a Business Name"; and
  - b. deleting (8) in Appendix 3.

### D. Companies Act 2015 Requirement: a business name must be registered

- 5. Pursuant to section 32 of the Companies Act 2015, all firms, individuals and companies are required to register their business name as follows:
  - a. <u>every firm having a place of business in Fiji</u> and carrying on business in Fiji under a business name which does not consist of the true family names of all partners who are individuals and the company names of all partners who are companies or foreign companies without any

addition other than the true first names of individual partners or initials of such first names;

- b. <u>every individual having a place of business in Fiji and carrying on</u> <u>business in Fiji under a business name in Fiji</u>; and
- c. *every company and foreign company carrying on business in Fiji* under a business name which does not consist of its full company name as registered under this Act without any addition, must have a business name registered under this Act.
- 6. Refer to *Appendix 1* for the sample of the certificate of registration of a local company, *Appendix 2* for the sample of the certificate of registration of a foreign company and *Appendix 3* for the sample of certificate for a registration of a business name.

#### E. Identification and Verification of Business Customers

- 7. Where a customer is a <u>natural person</u>, a financial institution may use at least one ID document provided in List A-Appendix 1, together with other ID documents provided in List B- Appendix 1 of the FIU Enforceable Guideline #4, one of which may be the "Certificate of Registration of a Business Name".
- 8. Where a customer is a <u>legal entity</u>, a financial institution may use relevant ID documents provided under Part 3 and Appendix 3 of the FIU Enforceable Guideline #4, one of which may be the "Certificate of Registration of a Business Name".

#### F. Compliance

- 9. The FIU and/or the relevant supervisory authority, in the course of its supervision, may assess the compliance of financial institutions' with the requirements of this Policy Advisory.
- 10. Non-compliance may result in sanctions as specified in section 43(2) of the FTR Act and regulation 42(2) and 42(3) of the FTR Regulations.
